Re: 2017 Pickaway County Septage Hauler Registration

Dear Pickaway County Registered Septage Haulers:

Enclosed you will find the 2017 application to register to provide services as a septage hauler in the Pickaway County General Health District. **Your 2017 application must include the following:**

1. Registration Application along with septage hauler registration fees.
2. Proof of passing the Testing Requirements.
3. Proof of compliance with any system specific training, qualification, or certification required as a condition of a system's approval by the director.
4. Proof of General Liability insurance of not less than \$500,000 (original to be filed with Ohio Department of Health and a copy provided with your registration application).
5. Proof of a surety bond (to be filed with Ohio Department of Health and a copy provided with your registration application).
6. Proof of 6.0 hours or more of ODH approved continuing education credits completed during the 2016 calendar year.
7. **Any outstanding forms, required pumping reports, service records, or other documentation for all work completed in 2016 that have not been submitted to the local health district. Failure to submit all required reports will result in disapproval of you 2017 registration.**

Renewals for 2017 Registration will not be approved until all of the above documents are submitted to our office. We are requiring all of the above documents to be submitted along with your renewal application to prevent disapproval of your 2017 registration any of the above mentioned paperwork not included will result in everything being returned to you.

Please remember, registration must be approved prior to conducting any work or performing services of septage hauling in Pickaway County in 2017. Registration fees currently are \$195.00 and \$50.00 per truck.

You can contact our office to schedule truck inspections at 740-477-9667 ext. 225. If you have already had your truck(s) inspected by your home county we will accept those inspections.
